The Kern County Elections Division is preparing for the November 8, 2022 General Election. Enclosed is a packet with all necessary forms to gather the most current information for the candidates whose terms are up for election. Please review, have the District Secretary sign, and return the original Notice of Elective Offices Form to this office. Please return the Notice of Elective Offices to be Filled with the District Request for Consolidated Election Services on or before **July 6, 2022**, pursuant to the provisions of Section 10509 of the Elections Code.

Please advise board members and other potential candidates as follows:

Declaration of Candidacy forms will be available by appointment or email request to candidate filing@kerncounty.com from July 18, 2022 until August 12, 2022 at 5:00 pm in the Elections office. Candidates wishing to submit a Candidate's Statement, of no more than 200 words, for printing and distribution to the voters must submit such Statement for filing at the same time the Declaration of Candidacy is filed. The statement must be prepared on a form supplied by the Elections Division.

Unless the District has elected to cover costs, the provisions of Elections Code Section 13307 provide for payment of the estimated cost of printing and handling the Candidate Statement at the time of filing the Declaration of Candidacy.

The costs for Candidate's Statements will be determined when redistricting process has been completed. Estimated candidate statement costs shown for cities, schools, and special districts are based on the election method (i.e. at large or by trustee area) and district boundaries in place at the time the estimate is prepared.

If your board has made appointments to fill vacancies pursuant to Government Code Section 1780, please bear in mind that by the provisions of subdivision (d)(2) "the person appointed to fill a vacancy shall hold office until the next district general election." This means that where an appointment has been made to replace a director whose term would not have expired until 2022, an election must be held this coming November to fill the unexpired portion of the term.
